Preceedings of the Annual Convention
held at**

**American Legion Post #156, Waltham, Mass.
March 16, 2024**

The Annual Convention of the Unified Libertations of Massachusetts was held at the American Legion Post #156, 215 Waverly Oaks Rd., Waltham. The convention was called to order by Chairman Dave Burnham at 10:13 A.M.

The Chairman welcomed the attendees, and began a wrap-up of the previous year, noting Stephanie's membership initiative, Tom's work in the Treasury, the collation work, such as PorcFest, Jason's work with Stop the Shock, Brian's work with Defend the Gaurd. Janel's press with her State Senate run, and the Commonwealth being forced to print more Libertarian ballots, and Charlie's interview with it with the Attleborough Sun-Chronicle.

With a short attendance, a large number of those present signified they would serve as Delegates. Charlie noted Janel Holmes and Paul Lynch will serve as delegates, Brodi noted Brian Z. will serve as a delegate.

Stephanie spoke about her membership initiative and her hopes for future growth with it. After her presentations, the Chairman acknowledged her hard work.

Peter Everett spoke favorably on the Presidential dinner forum last night, and the Chairman noted that it is now a recommended practice that we do this event for each Presidential cycle, and then do this for state-wide and legislative elections.

For by-laws changes, Stephanie Pazniokas made a motion that Art. III, Sect. 4 be revised to read, in brief, that current members of the state party, to include the national party or those who dues had expired within 90 days prior, will be allowed to vote, if dues are renewed by, or at the convention. Dr. Everett asked if this affects non-resdients. The motion passed.

Delegates: 22 persons are interested. Peter Everett motioned to vote the slate, the vote was 13-10, but not being 2/3, the motion failed. The question was then posed to do a hand vote. The slate passed. The Excel containing the delegates has been attached to the end of the minutes as an addendum.
