



# **Meeting Minutes**

#### Call to order

A meeting of the Unified Libertarians of Massachusetts was held at 8:00 pm on January 16, 2025 via Jitsi. ## Approval of Agenda/Previous Minutes

The agenda was approved. The minutes for the December 2024 meeting were approved unanimously by voice vote.

## Chair's Report

Facilitated further disbursements from the KVF

Zoom call with Brian and the Director of Massachusetts Peace Action, who wrote 2 state senators and pledged his support for our DTG bill

Followed up with my State Rep about the DTG bill and requested that she sponsor it (not just file it) Senator Jehlen informed me she will be sponsoring it and testifying

Sent final draft to my State Rep for filing in the House chamber

Sean Kennedy suggested that the party send out a test mailer and see what return we get on activity from those mailers.

James Parent reported that he found a venue, the Moose Lodge in Plymouth. He will test it out this weekend. It costs \$300 for the day. He reserved it from 1:00 to 5:30 pm, and suggests having a social event at the end. He is looking for a speaker or comedian for fundraising.
